This is in furtherance to the intimation dated November 22, 2022 wherein the Company had informed that MacRitchie Investments Pte. Ltd., an indirect wholly owned subsidiary of Temasek Holdings (Private) Limited in partnership with the Company had entered into Contribution Agreements for about 50% of total corpus of each scheme of Info Edge Venture Fund, Info Edge Capital and Capital 2B- Alternative Investment Funds (AIFs), registered with SEBI as Category II AIFs, under the SEBI Alternative Investment Funds Regulations, 2012, sponsored through Smartweb Internet Services Limited, its wholly owned subsidiary.

This is to further inform that IE Venture Investment Fund II, a scheme of Info Edge Capital Fund and Capital 2B Fund I, a scheme of Capital 2B Fund have now entered into Contribution Agreement with DFOSG Pte. Ltd. (DFOSG), for a contribution commitment of INR 140.625 Crores and INR 70.313 Crores in their respective schemes.
