In furtherance of our intimation/disclosure dated July 26, 2023, we would like to inform you that Hon'ble Justice Mukta Gupta (Retd.), the sole arbitrator appointed in the petition filed by Allcheckdeals India Private Limited (a wholly owned subsidiary of the Company) ("AIPL") against 4B Networks Private Limited ("4B Networks"), Mr. Rahul Yadav and Mr. Pratik Choudhary (4B Networks, Mr. Rahul Yadav and Mr. Pratik Choudhary being collectively referred to as "Respondents"), has passed an order on the interim relief applications filed by AIPL ("Interim Order").
