ORDER

PER: BHASKARA PANTULA MOHAN, MEMBER (JUDICIAL)

Under consideration is Company Petition 55/PB/2021 filed under Sections 230 to 232 of the Companies Act, read with the 2013 Companies (Compromises, Arrangements & Amalgamations) Rules. 2016. The purpose of the Company Petition is to obtain sanction of the Scheme of Amalgamation (in short, "Scheme") by virtue of which M/s Highorbit Careers Private Limited (hereinafter referred as "Transferor/Petitioner Company-1"), is proposed to be merged with M/s Info Edge (India) Limited (hereinafter referred to as "Transferee/Petitioner Company-2") as a going concern.

2. The Transferor/Petitioner Company-1 is a Private Limited Company and was incorporated under the Companies Act, 1956 on 30.08.2010 under the name and style of "M/s Highorbit Careers Private Limited" which is having its registered office at GF-12a, 94, Meghdoot Building, Nehru Place, New Delhi- 110019 and engaged in

the business of providing online classifieds, database, digital platform and recruitment solutions in the recruitment and employability vertical to small, medium and large enterprises and job seekers across different verticals particularly (in the case of www.iimjobs.com) mid and senior management verticals and (in the case of www.hirist.com) engineering technology verticals and other related activities.

3. The Transferee/Petitioner Company-2 was originally incorporated under the Companies Act, 1956 as a private limited company with the name and style as 'Info Edge (India) Private Limited on 01.05.1995 at the Registrar of Companies, NCT of Delhi and Haryana, New Delhi. The Company was further converted into a Public Limited Listed Company and the name of the Company was changed to its present name "M/s Info Edge (India) Limited" vide its fresh certificate of incorporation dated 27.04.2006 having its registered office at GF-12A, 94, Meghdoot Building, Nehru Place, New Delhi-110019 and engaged in the business of internet based service delivery operating in four service verticals through various web portals in

respective verticals namely recruitment solutions comprising primarily Naukri.com, other recruitment, 99 acres.com for real estate related services, jeevansathi.com for matrimony related services and shiksha.com for education related services.

- 4. The Transferor Company is a wholly owned subsidiary of the Transferee Company. Hence, no new shares will be issued by the Transferee Company pursuant to the Scheme of Amalgamation.
- 5. Both the Petitioner Companies are registered at the Registrar of Companies at New Delhi. The Board of Directors of the Transferor Company and Transferec Company vide Board Resolution dated 10/02/2020 approved the said Scheme of Amalgamation.
- 3. This Tribunal vide its order dated 10/02/2021 in CA(CAA)127/PB/2020 directed to convene the meetings of the Equity Shareholders, Secured and Unsecured Creditors of both Petitioner Companies on 12.04,2021. This Tribunal had further directed the Petitioner Companies to issue


notices to the statutory authorities and the notices were issued. Further, the Petitioner Company was directed to effect paper publication in "Business Standard" (English, Delhi Edition) and "Business Standard" (Hindi, Delhi Edition). The aforesaid direction given by this Tribunal in the vide order dated 19.05.2021 in CAA-55(PB)/2021, has been complied by the Petitioner Companies.

4. The Counsel appearing on behalf of the Petitioner Companies submitted that the proposed amalgamation of the Transferor Company into the Transferee Company is in pursuant to a Share Purchase Agreement dated 27.05.2019, the Transferee Company had acquired entire share capital of the Transferor Company on 25th June, 2019, with an objective to further consolidate its position in the online recruitment solutions segment where its flagship brand Naukri.com already has an established leadership position. The similarity in the nature of the businesses of the Transferor and Transferee Company, it is proposed to merge the Transferor Company, with the Transferee Company. This merger would result in greater business

synergies and reduced administrative and other costs with below mentioned benefits:

- a) Structured, sharper and better management focusing on holistic growth of the business;
- b) Optimum and efficient utilization of resources and sharing of ancillary facilities;
- c) Common governance structure and effective management of compliances;
- d) Enhancing shareholder value and leveraging on synergies in doing the business; and
- e) Cost saving by way of reduction of overheads, administrative, managerial and other expenditure and to bring about operational rationalization and efficiency.
- 5. The Regional Director (Northern Region), MCA has filed his representation affidavit dated 28.07.2021 along with the report of the Registrar of Companies, New Delhi. The Petitioner Companies have also filed their reply to the observation and report of the ROC and RD.
- 6. On Examination of the Scheme and the reply submitted by the Petitioner Companies the Observations of the Regional Director is reproduced here under:



- 1. The Regional Director had stated that as per the report of ROC the Transferee Company and the Transferor companies have filed their Annual Return and Balance Sheet up to 2019-2020 and no prosecution has been filed no inspection or investigation has been conducted in respect of the petitioner companies. The report of the Regional Director further stated some observations in its report are as follows:
- 2. The Scheme partakes merger of the Transferor Company with the Transferee Company whereas the Transferor Company is a wholly owned subsidiary company of the Transferee Company and the Transferee Company is a listed company.
- 3. On perusal of the contents of the scheme along with the reply of the petitioner companies and the report of ROC, Delhi it appears that the scheme covers the matter as applicable in this regard and also the petitioner companies have complied with the procedures laid down under the provisions of section 230-232 of the Companies Act, 2013 read

with relevant Rules. In view of the Hon'ble Tribunal may consider for approval of scheme on its merit and also pass order as deemed fit and proper in this regard.

- 6. Further It is stated in para 11 of the Representation/Affidavit filed by the Regional Director, Northern Region, Ministry of Corporate Affairs, New Delhi on 28.07.2021, that as per the Report of the Registrar of the Companies, both Transferor and the Transferee Company have filed its Annual Return and Balance Sheet up to 2019-2020.
- 7. The Petitioner Companies in compliance with the orders of this Tribunal in 1st and 2nd motion Petitions have served their notices to the Income Tax Department. It seems that ITD have not submitted any report till today and no objection is being raised in sanctioning of this Scheme of Amalgamation.
- 8. In view of the above no objection given in the report of RD petition stands to be allowed. The Official Liquidator, Ministry of Corporate Affairs, New Delhi has also submitted



his report through a representation, wherein it has not raised any objection against the Scheme of Amalgamation.

- 9. The Official Liquidator has filed its report on 12.07.2021 wherein no material objection has been raised by them in relation to the Scheme. It submitted in the report that the official liquidator has not received any complaint against the proposed Scheme from any person/party interested in the Scheme in any manner and that the affairs of both Transferor and Transferee Companies do not appear to have been conducted in a manner prejudicial to the interest of its members or to public interest.
- 10. We have gone through the reports of the Ld. Regional Director (Northern Region), Ministry of Corporate Affairs, New Delhi, Ld. Official Liquidator, Ministry of Corporate Affairs, New Delhi and after perusing the same, we are of the view that the sanction of the present Scheme is not in violation of any provision of the Law as well as not against the public policy, nor it would be prejudicial to the public interest at large.

- 11. A certificate of Statutory Auditor of the Petitioner Companies have been placed on record to the effect that Accounting Treatment proposed in the Scheme Amalgamation is in conformity with the Accounting Standard notified by the Central Government as specified under the provisions of Section 133 of the Companies Act, 2013. The Appointed date of the said Scheme is 01.04.2020.
 - 12. There is no requirement for any modification and the said Scheme of Amalgamation appears to be fair and reasonable and is not contrary to public policy and not violative of any provisions of law. All the statutory requirements of sections 230 to 232 of the Companies Act, 2013 are complied with. Taking into consideration the above facts, the Company Petition is allowed and the Scheme of Amalgamation annexed with the Petition is hereby sanctioned which shall be binding on the members, creditors and shareholders of the Transferor Company.
 - 13. While approving the scheme as above, we further clarify that this order will not be construed as an order granting exemption from payment of stamp duty or taxes or any

other charges, if payable, as per the relevant provisions of law or from any applicable permissions that may have to be obtained or, even compliances that may have to be made as per the mandate of law.

- 14. The Companies to the said Scheme or other person interested shall be at liberty to apply to this Bench for any direction that may be necessary with regard to the working of the said Scheme.
- 15. The Transferor Companies shall be dissolved without winding up from the date of the filing of the certified copy of this order with the Registrar of Companies.
- 16. The Transferor Companies are directed to file the certified copy of this order along with a copy of the Scheme of Amalgamation with the concerned Registrar of Companies, electronically along with E-Form INC-28, in addition to physical copy, as per the relevant provisions of the Companies Act, 2013 within 30 days of receipt of the order.
 - 17. Accordingly, the Scheme stands sanctioned and CAA-55/PB/2021 stands disposed of.

1.2 Info Edge (India) Limited is a company incorporated under the Companies Act, 1956 with its registered office at Ground Floor, GF-12A 94, Meghdoot Building, Nehru Place, New Delhi - 110019, India ("Transferee Company" or "Info Edge") [CIN: L74899DL1995PLC068021].

Info Edge is primarily engaged in the business of internet based service delivery operating in four service verticals through various web portals in respective verticals namely recruitment solutions comprising primarily naukri.com, other recruitment related portals and ancillary services related to recruitment, 99acres.com for real estate related services, jeevansathi.com for matrimony related services and shiksha.com for education related services.

PART I DEFINITIONS AND SHARE CAPITAL

1. DEFINITIONS

- "Effective Date" means the date or last of the dates on which certified copy of the order of the Tribunal sanctioning this Scheme is filed with the Registrar of Companies, Delhi and Haryana, by the Transferor Company and the Transferee Company, being the date from which such order shall become effective. Any references in the Scheme to "upon the Scheme becoming effective" or "effectiveness of the Scheme" or "Scheme coming into effect" shall mean the "Effective Date".
- "Governmental Authority" means any applicable central, state or local government, legislative body, regulatory or administrative authority, agency or commission or committee or any court, tribunal, board, bureau, instrumentality, judicial or quasi-judicial or arbitral body having jurisdiction over the territory of India;
- 1.7 "Highorbit" or " Transferor Company " means Highorbit Careers Private Limited (CIN: U72900DL2010PTC207653), a company incorporated under the Companies Act, 1956, with its registered office at GF-12A 94, Meghdoot Building, 94, Nehru Place, New Delhi 110019, India.

- 1.13 "Stock Exchanges" means the BSE Limited and National Stock Exchange of India Limited;
- 1.14 "Tax" or 'Taxes' means any and all taxes (direct or indirect), surcharges, fees, levies, cess, duties, tariffs, imposts and other charges of any kind in each case in the nature of a tax, imposed by any Governmental Authority (whether payable directly or by withholding), including taxes based upon or measured by income, windfall or other profits, gross receipts, property, sales, severance, branch profits, customs duties, excise, Cenvat, withholding tax, self-assessment tax, advance tax, service tax, central goods and services tax, state goods and service tax, integrated goods and service tax, stamp duty, transfer tax, value-added tax, minimum alternate tax, banking cash transaction tax, securities transaction tax, taxes withheld or paid in a foreign country, customs duty and registration fees (together with any and all interest, penalties, additions to tax and additional amounts imposed with respect thereto);

- 12.2 Upon the Scheme becoming effective, the Transferee Company is expressly permitted and shall be entitled to revise its financial statements and returns along with prescribed forms, filings and annexures under the IT Act, as amended, (including for minimum alternate tax purposes and tax benefits,) GST law and other tax laws, and to claim refunds and/or credits for Taxes paid (including minimum alternate tax), and to claim tax benefits under the IT Act and other tax laws etc. and for matters incidental thereto, if required to give effect to the provisions of this Scheme.
- 12.3 Any Tax liabilities under Tax laws allocable or related to the Transferor Company, to the extent not provided for or covered by tax provision in the accounts made as on the date immediately preceding the Appointed Date, shall be transferred to the Transferee Company.
- Any surplus in Taxes/ surcharge/cess/duties/ levies account including but not limited to advance income tax, tax deducted at source, MAT credit, GST / Cenvat and any tax credit entitlements under any Tax laws as on the date immediately preceding the Appointed Date shall also be transferred to the Transferee Company, without any further act or deed.
- 12.5 Any refund relating to Taxes which is due to the Transferor Company including refunds consequent to the assessments made on it and for which no credit is taken in the accounts as on the date immediately preceding the Appointed Date shall also belong to and be received by the Transferee Company.
- Upon the Scheme coming into effect on the Effective Date and with effect from the Appointed Date, all deductions related to Taxes otherwise admissible to Transferor Company including payment admissible on actual payment or on deduction of appropriate Taxes or on payment of tax deducted at source (such as under Section 43B, Section 40, Section 40A, etc. of the IT Act) shall be eligible for deduction to the Transferee Company upon fulfilment of the required conditions under applicable Tax law.
- 12.7 Since each of the permissions, approvals, consents, sanctions, remissions, special reservations, goods and service tax exemptions, incentives, concessions and other authorizations of the Transferor Company shall stand transferred by the order of NCLT to the Transferee Company, the Transferee Company shall file the relevant intimations, for the record of the statutory/tax authorities who shall take them on file, pursuant to NCLT's vesting orders.
 - The withholding tax/ advance tax/ minimum alternate tax, if any, paid by the Transferor Company under the IT Act or any other statute in respect of income of the Transferor Company assessable for the period commencing from the Appointed Date shall be deemed to be the tax deducted from/advance tax paid by the Transferee Company and credit for such withholding tax/advance tax/minimum alternate tax shall be allowed to the Transferee Company notwithstanding that certificates or challans for withholding tax/advance tax are in the name of the Transferor Company and not in the name of the Transferee Company.
